DRUG POLICY: HARM PREVENTION VS HARM REDUCTION – IMPORTANT TO KNOW THE DIFFERENCE

Americans Against Legalizing Marijuana provides information on the harms of marijuana to individuals and our country based on the science and on the premises of “No Use of Any Illegal Drugs” and “No Illegal Use of Legal Drugs.”

AALM supports Harm Prevention and opposes strategies that support ongoing drug use. We do not consider programs such as needle exchange and safe injection sites that allow for continued drug use to be effective in reducing harm.

Harm Reduction policies as promoted by the marijuana lobby have always been a deceitful scheme aimed at maintaining use of harmful illegal drugs.

HARM PREVENTION

Harm Prevention has the best potential for effectively and humanely addressing the drug problem and protecting individuals and the community from drug related harm.

In the past, Harm Prevention programs, policies and other strategies caused a positive change in public attitudes about illicit drugs, which resulted in significant decline in drug use, especially by youths. A social context in which drug use is not accepted is essential in decreasing drug use.

Research has shown that there is a direct correlation between the perception of harm and drug use trends among young people.

Harm Prevention has a proven track record. During the Reagan Administration in the 1980s, our drug policy had a united and consistent voice about the dangers of marijuana and other illicit drugs. Parents, educators, business leaders, sports figures and other community leaders worked hand in hand with government at the local and national levels with strong anti-drug messages. They turned the tide against the use of harmful drugs that resulted in a significant decline in drug use across America at that time.

Harm Prevention supports sobriety standards in treatment and recovery and mandated treatment, where needed, as it is about the prevention of ongoing harmful drug use and the saving of lives.

The emergency use of Naxolone is a life-saving strategy for overdose cases. It does not support ongoing drug use. Anyone who overdoses should be referred to or mandated to go to treatment.

With needle exchange legislation before the California legislature in 1989, prominent African American Congressman Charlie Rangel said to drug prevention advocates that needle exchange program would be the genocide of his people.

MANDATORY TREATMENT AND REHABILITATION ARE NO LONGER PART OF HARM REDUCTION PROGRAMS

Many harm reduction programs and housing programs no longer support sobriety standards.

Amid towering, unoccupied office buildings, San Francisco's open air drug markets allow cartel-backed dealers to roam free, while a multi-million dollar industry of nonprofits such as the Drug Policy Alliance vocally reject treatment as a viable solution. It's no surprise that residents at the front lines are fed up with the results.

Drug legalization advocates use harm reduction as drug use maintenance and so called “safe use” of harmful, illegal drugs.

The Drug Policy Alliance, founded by George Soros and Ethan Nadlemann of the Lindesmith Center, leading proponent of drug legalization, since 1990, has spent over \$300 million promoting the legalization of harmful drugs.

The Drug Policy Alliance supports harm reduction as a way to meet people where they are and to form connections give people with tools that reduce the risks of drug use - not to get people off drugs. HARM REDUCTION PROGRAMS ARE FAILING

Ricci Wynne, a drug abstinence advocate and former drug dealer, told a news reporter that the homeless in San Francisco “don’t need more syringes, they don’t need crack pipes, they don’t need tinfoil. They need abstinence - based treatment, they need to get clean, they need help to get back on the road to recovery,” said Wynne.

In 2016, under Gov. Gavin Newsom, California adopted the Housing First program. It was aimed to get anyone experiencing homelessness into government-subsidized housing as quickly as possible, while also removing barriers to access the housing such as requirements for sobriety and no criminal background. However, San Diego County Supervisor Desmond said

“The state housing policy has backfired. If you had a loved one or family member that needed drug treatment or needed mental health treatment, would you send them to a facility that did not require programs or treatment? That’s exactly what the government is doing and that’s exactly what Housing First allows.”

The passing of California’s SB1380 in 2016 outlawed any sobriety or treatment requirements for homeless drug addicts receiving state-funded housing. As a result, nonprofits seeking access to the cash cow of public funding must push a Housing First ideology that rejects any form of abstinence-based treatment for homeless drug addicts.
